- a college faculty member preparing teacher candidates at the undergraduate or graduate level in one or more of the test fields.

- a **stipend of \$350 per meeting day**,
- flight arrangements or reimbursements for reasonable travel-related expenses, and
- **hotel accommodations** if necessary.
